He said the ECI told the party on Monday that even the "cup and saucer" symbol was also not available. The "key" symbol was reserved by other political outfits in September last year and the other two symbols in December.

Dushyant said the JJP discussed the issue of election symbol with party patron

Ajay Singh Chautala and thereafter decided not to field its candidates for the Delhi polls.

"If our candidates fight the polls on a new symbol, they may have to bear loss as a result," he added.

The JJP had been recognised as a "state party" in Haryana by the Election Commission and allotted "key" as its reserved symbol in the state.

thought-out" plan to distance itself from the present SAD leadership.

"It was a part of a well thought-out plan of the BJP to distance itself from the present SAD leadership because they are taking it as a burden because of their taint of drugs and sacrilege issues," Jakhar alleged here.

He said "Veteran Akali leader Sukhdev Singh Dhindsa was honoured with Padma Bhushan without the consent of the Akali Dal and

then by keeping it away in the Haryana Vidhan Sabha polls, the BJP made it clear it was no more interested in the SAD's current leadership." The SAD leadership is turning the party into "Badal Akali Dal," Jakhar said.

The former Gurdaspur MP also claimed that the saffron party had realised that the current leadership of the Shiromani Akali Dal has "lost" its base among the people and is "harming" the BJP's political prospects.
